Securing a decarbonised future for the maritime industry

As decarbonisation targets from the International Maritime Organisation (IMO) tighten, improving sustainability and cutting emissions is the maritime sector's biggest challenge. While the industry is working to reduce its reliance on traditional fossil fuels and transition toward low-carbon solutions, new investments, innovative digitalisation strategies and bold collective actions from governments, companies and private investors will be crucial to propelling the industry forward.

Leveraging digital technologies such as blockchain, machine learning (ML) and the Internet of Things (IoT) in the maritime and logistics ecosystem will be a crucial driver towards enhanced performance and optimal efficiencies. Digital pioneers in the sector are already leading the way by developing smart ports, utilising automation technologies and harnessing Artificial Intelligence (AI) to make more insightful decisions across their operations while connecting people, organisations and resources in an interactive digital ecosystem.

The International Maritime Organisation's (IMO) revised 2023 strategy sets out a clear target to reduce GHG emissions by 86% by 2040. Shipping operators must align with global net-zero ambitions, working together to establish cohesive global approaches to decarbonise the maritime sector.

As the industry confronts the divide between conventional and future fuels, it is imperative for all stakeholders to adopt actionable cross-sector strategies to release bottlenecks and secure offtake agreements. Maritime industry leaders are prioritising ramping up energy efficiency and integrating technologies to lower demand and improve fuel cleanliness. The readiness of ports for an alternative energy future will be a pivotal part of the maritime decarbonisation journey, balancing the urgency of infrastructure developments with the availability of new fuels. Additionally, the role of shipping in maintaining robust, sustainable global trade, particularly during geopolitical upheavals, will be examined for its agility and resilience.

The Maritime & Logistics conference will shape pragmatic and transparent discussions and foster the cross-industry collaboration needed to find tangible decarbonisation solutions that can accelerate industry-wide transformation, a critical step in delivering a clean energy future while maintaining equitable economic growth.





